1. Welcome & Opening

- **Call to Order:** Meeting was formally opened.
- **Prayer:** Led by Elder Joshua Isaboke, invoking wisdom, guidance, and unity.
- **Introductions:** Attendees shared names, roles, and affiliations, highlighting diverse expertise in community development, mental health, financial services, policy, and youth empowerment.

2. Coalition Foundations

- **Bylaws:** Reviewed and ratified.
- **Mission, Vision, and Purpose:**
 - *Purpose:* Create a supportive and inclusive coalition to empower refugees and immigrants in their mental health journey by fostering resilience, preventing suicide, and promoting overall well-being.
 - *Mission:* Unite community members, organizations, and stakeholders to provide culturally responsive resources, raise awareness, and create a strong support network.

- *Vision:* A united and compassionate community where refugees and immigrants are resilient, supported, and free from stigma in mental health and suicide prevention.
- **Decision:** All statements were adopted unanimously.

3. Leadership Messages

- **Founder's Remarks (Dr. Tolulope Ola):**
 - Coalition is *not owned by REFA* but a community-wide initiative.
 - Envisioned the coalition standing independently in the future.
 - Encouraged collective decision-making and unity.
- **Chair's Remarks (Dr. Richard Oni):**
 - Coalition is "concerned citizens with a common goal."
 - Urged members to treat the coalition as bigger than any individual.
- **Vice Chair's Remarks (Elder Joshua Isaboke):**
 - Stressed teamwork: *Together Everyone Achieves More.*
 - Advocated for collaboration over competition, listening to one another, and fostering resilience.
 - Inspired members with the metaphor of the lion's courage and strength.
- **Additional Reflections:**
 - *Roselidah Nyaboke:* Highlighted the importance of speaking up for the community.
 - *Harriet Kerubo:* Called for cross-sector collaboration (policy, education, and economic development) and cultural pride.

4. Officer Selection & Roles

- **Confirmed:**
 - *Chair:* Dr. Richard Oni
 - *Vice Chair:* Elder Joshua Isaboke
 - *Coordinator:* Victor Obisakin
- **Vacant:**
 - *Secretary:* Two candidates (Heritage Aluko and Harriet Kerubo). Election scheduled for the September 23 meeting.
 - *Treasurer:* No volunteers yet. Recruitment ongoing.
- **Roles Overview:**
 - *Chair:* Preside over meetings, lead planning, and oversee committees.
 - *Vice Chair:* Support Chair, co-lead initiatives, assume duties in the absence of the Chair.
 - *Secretary:* Maintain agendas, minutes, and records.
 - *Treasurer:* Manage finances, provide reports, support fundraising.
 - *Coordinator:* Handle logistics, communications, and serve as interim support for vacant roles.

5. Coalition Operations

6. Planning Ahead

- **Committees/Workgroups:** Proposed – Advocacy, Events, Research, Fundraising, and Policy. Membership and leadership to be confirmed.
- **Community Engagement:** Strategies to involve youth, elders, and culturally diverse voices.
- **Accountability:** Coalition agreed on the need for systems to track progress and report back consistently.

7. Open Forum

- **Henry Momanyi** cautioned that many coalitions collapse due to a lack of respect for leadership and accountability. Urged members to respect each other's space, leadership, and responsibilities.
- Members echoed the need for equity, collaboration, and cultural pride.

8. Closing

- **Final Reflections:**
 - Members expressed gratitude and optimism for the coalition's vision.
 - *Helen Ghebre* joined late, introducing herself as a DHS staff member and community member, committed to supporting coalition goals.
- **Closing Prayer:** Led by Roselidah Nyaboke, lifting up the coalition's leaders, members, and community.
- **Adjournment:** Meeting ended at 2:00 PM CST.
